## Observation Report:

The Contractor requested a final punchout inspection at the 05/06 balcony stack. The completed paint, sealant and deck coating application was inspected at each unit. The paint application appeared professional with no holidays observed. The applied sealants were properly tooled and compressed. Deck coating was evenly applied and continued up the cant bead as specified. The following items were noted for the Contractor to correct: 22B5-paint on shutter, 18B6-touch up deck coating at cant bead, 16B6-fill in hole on East wall, 16B5-repair deck coating at West SGD cant bead, 12B5-repair deck coating between both SGD's at cant bead, 6B5-repair deck coating in field/re-apply deck coating topcoat between knee wall and shutter track, 5B5-repair cant bead and stucco bottom right corner of West SGD, 4B6-remove screws from ceiling edge, 2B5-repair hole on floor/repair deck coating at West SGD cant bead, 1B5holidays on ceiling(concrete repair work left to complete at edge), 1B6-holiday on ceiling. The swing stage is approved to be re-located to the next drop following completion of the items listed above.

Stucco application is in-progress at the 01/06 balcony stacks. The Contractor anticipates on finishing the stucco work, installing louvers and beginning paint work next week. Replacing the parpapet urethane joints is in-progress at the parapet wall above the 02 stack window wall.

Concrete repair is in-progress at the 03/04 balcony stacks.
